I. CALL TO ORDER

The meeting was called to order at 2:01 p.m. Those present were Hearing Officer Sam Starritt, City Attorney John Shaver, and City Records Manager Debbie Kemp.

II. APPLICATION TO RENEW LIQUOR AND BEER LICENSES

 Myths & Legends, Inc. dba Quincy Bar & Grill, 609 Main Street, Grand Junction, CO 81501, Tavern

The renewal application for Myths & Legends, Inc. dba Quincy Bar & Grill was found to be in order and approved.

2. Zen Garden, Inc. dba Zen Garden, 2886 North Avenue, Grand Junction, CO 81506, Hotel & Restaurant

Chiew Chiou, owner of Zen Garden, was present.

Ms. Kemp said the review agencies reported the establishment is in compliance except with the Fire Department. The Fire Department asked for a conditional approval to be reviewed in 30 days to allow time for a new hood fire suppression system to be installed.

Mr. Chiou stated the system should be installed October 17, 2018.

The renewal application for Zen Garden, Inc. dba Zen Garden was approved conditionally. If the Fire Department does not report a satisfactory inspection, the renewal should be placed on the November 21, 2018 Liquor and Beer meeting agenda.

3. Inafuku, Inc. dba Suehiro Japanese Restaurant, 541 Main Street, Grand Junction, CO 81501, Hotel & Restaurant

The renewal application for Inafuku, Inc. dba Suehiro Japanese Restaurant was found to be in order and approved.

III. APPLICATION FOR NEW LIQUOR LICENSE – RESOLUTION, FINDINGS, AND DECISION

Thai Smile owner Naiyana Pedersen was present.

Ms. Kemp reported the paperwork was in order and read the results of the survey (attached).

City Attorney Shaver asked Ms. Pederson questions about how the survey to determine the needs and desires of the neighborhood was conducted and if she felt the results Ms. Kemp reported were true and accurate. Ms. Pederson answered the questions and felt the results reported were true and accurate.

Fiesty Pint owner, Timothy Babbitt and circulators of the survey Tyler Higgins and Amber Brown were present.

Ms. Kemp reported the paperwork was in order but the Fire Department had not conducted an inspection due to construction. She read the results of the survey (attached).

City Attorney Shaver asked questions about how the survey to determine the needs and desires of the neighborhood was conducted and if he felt the results Ms. Kemp reported were true and accurate. Mr. Babbitt, Mr. Higgins, and Ms. Brown answered the questions and felt the results reported were true and accurate.

Hearing Officer Starritt asked if anyone was present to speak against the application. There was no one. Based on the information presented, there was no evidence that the application would not meet the needs and desires of the neighborhood despite that the number of signatures obtained were low, the application for Flattop Bar & Grill, LLC, dba Feisty Pint was approved pending

satisfactory inspection by the Fire Department. The City Clerk's Office will prepare a resolution of findings for Hearing Officer Starritt's signature.
