Please make note of the following clarifications:

1. Contractor shall utilize the attached updated Price Bid Schedule when submitting their bid response.
2. The new system does not need to have additional outside air piped in.
3. All electrical requirements for the project, to include disconnect of existing, and reconnect of new equipment shall be the responsibility of the Contractor. This shall also be true for the Add/Alternate Option item.
4. There will be no SCUBA tank fills needed for this unit.
5. The minimum psi for the new unit shall be 6,000 psi.
6. The new unit shall have a cascade system.
7. The new system can be an all-in-one unit or separate units.

The original solicitation for the project noted above is amended as noted.
