Please make note of the following:

1. Question: Description Items 10/11: For Height Raised 125" minimum, Mast Height Lowered 84" MAXIMUM? 2 or 3 Stage Mast?

Answer:

<u>Item #10</u>. The minimum fully raised fork height shall be 125". A fully raised fork height of greater than 125" is acceptable.

<u>Item 11</u>. This is worded incorrectly, and should read: **Mast overall lowered maximum height 84**". The maximum lowered mast height shall be 84".

2 or 3 stage mast. Either is acceptable.

The original solicitation for the project referenced above is amended as noted.

All other conditions of subject remain the same.
