- 3. Further clarification for flagstone steps: Construction Plans sheet C-15 calls for sandstone steps. This is an error and is incorrect. Flagstone steps shall be flagstone only?
- 4. Q. Please verify the root ball depth within Detail 4, "Cottonwood Deep Planting" detail, as shown on sheet L-04 of the landscaping plans?
- A. The root ball depth in the "Cottonwood Deep Planting" detail, as shown on sheet L-04 is correct.
- 5. Q. What are the planting time frames associate with the Willow trees and Cottonwood trees?

A. The planting schedule timeframe for the Cottonwood trees shall be between late October and mid-December. The planting schedule timeframe for the Willow trees/stakes shall be between late October and Mid December. Harvesting of Willow stakes shall begin during mid-October.

The original solicitation for the project noted above is amended as noted.
