ADDENDUM NO. 1

DATE: April 19, 2024 FROM: City of Grand Junction Purchasing Division TO: All Offerors RE: Precast Reinforced Concrete Box Culverts IFB-5433-24-KH

Offerors responding to the above referenced solicitation are hereby instructed that the requirements have been clarified, modified, superseded and supplemented as to this date as hereinafter described.

Please make note of the following clarifications:

1. **Q:** Is the City planning to self-perform the installation of these culverts as well as cast-in-place headwalls, wingwalls, and aprons, or will that come out as a separate bid solicitation?

A: The culverts will be installed, and the cast-in-place concrete constructed as part of a larger, separate solicitation for the overall Monument Connect Trail - Phase 2 project to be let later this spring. The City is not self-performing this work.

 Q: Is it expected for the supplier to have the means (equipment) to offload the box culverts at the City yard or will there be City supplied equipment and personnel to offload the structures? I ask this because the manufacturer will only be able to ship the structures on flat bed semitrucks with no means to offload the structurers themselves.

A: The City does not own the equipment needed to offload the heavy concrete box culverts at the City site. Please include the cost for the culverts to be unloaded at the site when the truck arrives. The supplier will need to work with a local contractor to unload the culverts.

3. **Q:** I have a question on section 1.3 Purpose. Instead of delivering it to the City Shop can we have it sit in our yard until you need it? So, that is saves money and time for the City, contractor, and Supplier? I guess that does depend on when the City plans on set the box?

A: Yes, this would be an option for the City. The plan is to have the boxes set before the end of 2024.

Contractor shall utilize the addendum one version of the price bid schedule when submitting a bid.

4. Section 3.3.6. Delivery Location shall be updated to the following:

Delivery Location: Items shall be delivered and unloaded "F.O.B. Destination – Freight Prepaid and Allowed" to:

Clymer site adjacent to the City Cemetery

Southwest of the US highway 50 and 26-1/4 Road intersection (39.047278 N, -108.56853 E) If pricing
